1. **Volunteers impact on specific community economic development initiatives over the past year.**

Examples include, but are not limited to: chartering or revitalizing private/public economic partnerships, policy/legislative development deemed essential to economic development efforts, etc. Please list volunteer positions/titles held by the nominee.*

## Criteria for Jim Spradley Volunteer of the Year Award

2. **Volunteers impact on specific economic development projects over the past year.**

(500 words or fewer.)

*Include name and description of the project(s) that the nominee assisted in locating or expanding during the current calendar year, including the specific nature of effort exerted personally by the nominee to locate the facility/facilities. The nominating data should be factual, pertinent, and concise. Include information regarding the number of jobs created and the amount of capital investment, as this will be considered in relation to the size of the community.*

### Scoring Guidelines

0% - No response

10-30% - Incomplete information or information not relevant to award or economic development.

40-60% - General information without specific details or without complete relevancy to the field of economic development.

70-90% - Relevant information that provides specific details of the nominees work in economic development. Points deducted for information that exceeds the 500 word limit.

100% - Complete, detailed, relevant information. Specific examples included of work and results that clearly defines significant contribution to the field of economic development and does not exceed the required length of 500 words per answer.
